

DuPont™ Tychem® F Accessory series of garments, manufactured using grey Tychem® F fabric with sewn internal seams with external over-taping.

The garment styles & size options are as follows:

- Gown (shin length) with closure at back, elasticated sleeves, which is available in two nominal sizes; Model PL50.
- b) Apron (shin length) with neck & waist ties, which is available in one size only; Model PA30LO.
- Sleeves (50 cm length) with elastication at cuffs & upper arm, which is available in one size only; Model PS32LA.
- d) Overboot (knee length) with a slip retardant sole stitched to the fabric (not a liquid-tight connection), which is available in one size only (maximum shoe size that can be worn is 45 (UK size 11); Model POBA.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC.
